Main results achieved and implementation performance of the project: After successful completion of phase-I Democracywatch along with other ANGOS has started the APARAJITA phase-II. The aim of phase-II is to keep EWRs, P-EWRs and NAV in track of political empowerment in order to allow them participate in the upcoming local government election. During the reporting period, 77 candidates contested from APARAJITA in Municipality election'15 for the position of councilor (reserve seat) where 26 candidates including 15 (52%) EWRs and 11 (38.8%) PEWRs elected. Only three (10%) of the elected women are outside from APARAJITA. Three women candidates from APARAJITA contested for Chairman position in UP Election 2016 and two of them have been elected. Ten candidates from APARAJITA contested for the member of general seat and two of them elected. In UP election of 2016, 1248 candidates from APARAJITA contested in reserved seat and 340 persons have been elected which includes 44 (10.8%) EWRs, 295 (72.6%) PEWRs and 1 (0.2%) of them are from NAV. Only 66 (16.3%) of the total elected women are outside APARAJITA intervention. Most of the newly elected persons has not yet taken oath and they did not get charge due to legal restriction. A total of 13 news published in different Print and Electronic Media regarding key stakeholders' proactively influencing gender-discriminatory policies and laws. 106 government officials, 23 civil society representatives, and 3 members of local government association were present in the advocacy event at national level. A total of 503 EWRs and PEWRs used Union Digital Center and 634 EWRs and PEWRs used Gender Resource Center of local office.	
Main steering implications for next period of interventions: In order to strengthen the process of women's political empowerment, more emphasis will be given to rapport building with newly elected UP Chairmen for sensitizing on WPE, lobby with political parties, Concern Ministry and constitutional institutions. Need special focus to strengthen Upazila Nari Unnayan Forum, strengthening Women-headed Standing Committees, sharing good practices through vertical and horizontal learning process, gender mainstreaming, ensuring women participation in open Planning and Budgeting, involvement of EWRs in ensuring accountability to service mechanism and organizing national level advocacy event. Strengthening outcome-based EWR, P-EWR and Volunteer-led monitoring process could be another major intervention during the next period.

Chapter 1: Introduction

After the successful completion of phase-I the program titled 'APARAJITA: Political Empowerment of Women, has extended for 15 months (December'15-February'17). Alliance of four partners NGOs - Democracywatch (DW), Khan Foundation (KF), PRIP Trust (PRIP) and Steps Towards Development (Steps) has been implementing the program accordingly with the support of Swiss Agency for Development and Cooperation (SDC). In this phase II, it has prepared a common chart of activities along with common goal and objectives. Democracywatch started carrying out its APARAJITA project intervention selected constituencies with the overall goal **"Disadvantaged and poor women improve their well-being through women political empowerment"**. As the APARAJITA program has adopted the constituency-based approach for implementation, DW, in the current Phase-II, is working in collaboration with the local administration and the civil society in 10 constituencies under the prescribed districts, i. e. Dinajpur, Rangpur, Nilphamari, Pabna, Sirajganj, Jessore, Narail, Magura, Mymensingh and Tangail consisted of 157 Union Parishad (UP), 15 Upazila Parishad (UZP) and 12 Municipalities. Targeted activities have been carried out as per annual plan of operation. The representatives of UPs, Upazilas, Municipalities and the civil society organizations were also mobilized through capacity building and advocacy initiatives especially to draw their attention on pro-poor services to be provided by the local level service providers. The project provided information service to the EWRS, P-EWRS, LGI and local community through Gender Resource Center.

The **Bi-Monthly** operational report is the document of the results of the first six months (December 2015 to May 2016) of the extending 15 months project interventions from December 2015 to February 2017 based on the outcomes and outputs.

Update of the stakeholder analysis: DW has successfully completed four (04) years of APARAJITA operation through vigorous interactions with different stakeholders and was able to adequately address the needs and interest of the primary target groups e.g. Elected Women Representatives (EWRs), potential women leaders and Networks of Activist Volunteers (NAV). Now DW is working for 2709 direct stakeholders which includes 536 Elected Women Representatives (EWRs), 1104 Potential Women Representatives (P-EWR), 1070 Volunteers and 1 Women Member of Parliament. During present phase there is considerable change among primary target groups engaged and substantially empowered due to Aparajita intervention during 1st phase. As per new election rule UP Chairman gets nomination from the political party. This Chairman in order to support the concern political party organized informal panel of candidates (those who will favor concern political party) to contest for UP election. This process eliminated most of the EWRs and PEWRs who were genuine candidates to participate as candidates for election both in UP reserved and general seats. Some of them were discouraged by the community and family to contest in the election because they thought the candidate will not be able to win the election because of dominance of political party. In spite of that a number of courageous EWRs and PEWRs contested in the election and some of the own the election As indicated in the case studies incorporated in the annex. In order to implement the planned activities smoothly, DW has interacted with relevant secondary stakeholders including Local Government Institutions (Union Parishad, Upazila Parishad and Municipality), Local Administrations (Central and Local Level), relevant Service Providers (GO-NGOs), Journalists and Community People.

Strategic link to the outcomes of SDC's Country strategy: According to Country Strategic Focus for Bangladesh on Local Governance, SDC in Bangladesh intends to facilitate decentralization and devolution of power to Local Government bodies by working directly with LGIs. Priority is given to enhance the role of the civil society in addressing the needs and rights of the poor and disadvantaged people. As APARAJITA project determined the expected 3 Outcomes, the focus of the project is very much in line with SDC's country and cooperation strategy including consideration of stakeholders, actors and local context.

Consideration of Poverty Issue in the Project Interventions: Overall women's contribution in development of Bangladesh is globally recognized. Unfortunately, the political space for women's participation still remains a challenge and "Poverty" cannot be addressed without involvement of "Women" in politics. The APARAJITA focuses on Women's Political Empowerment for expanding space of women in the political arena, targeting a gender responsive and equitable power structure. Ultimate goal is to enhance accessibility of the community people to the public services by the EWRs to empower grass roots and marginalized people and disadvantaged women for exercising their fundamental rights to free them from "Poverty", through the Safety Net Programs, which is contributing to poverty alleviation. DW has been providing capacity and confidence building support to the EWRs to raise their confidence level for performing their mandated roles and responsibilities targeting better living conditions of the constituents through this strategic intervention.

Chapter: 2

Outcomes Achieved for 1st six months of 15 Months Phase (Dec 2015 - May 2016)

During the reporting period from December 2015 to May 2016, the following achievements have been identified under the three Outcomes of the project:

Outcome # 1: EWRs and P-EWRs influence LGIs and local level decision making process

After completion of the intervention and activities in first six months of phase-II the following results have been achieved under outcome-1:

1.1: # of women candidates participated in Local Government election

Twenty nine EWRs, 47 PEWRs and 1 NAV and 54 candidates from non APARAJITA contested in Municipality election held in December 2015 where 15 EWRs and 11 PEWRs elected as councilor of reserve seats.

Three PEWRs and 4 Candidates from non APARAJITA (Two PEWR got support from Awami League) submitted nomination paper for Chairman Position in UP election 2016 among them one women candidates from non APARAJITA withdrawn nomination paper. Two women candidate from PEWR won in Chairman Position both are from AL.

Four EWRs, 4 PEWRs and 2 NAV submitted nomination paper for General seat (Member) Position in UP election 2016 (Three EWR and 1 NAV got support from Awami League) among them one EWR withdrawn nomination paper. 1 PEWR and 1 NAV won in General seat (Member) Position one of them from AL and another one from non party.

Three hundred six EWRs, 949 PEWRs, 2 NAV and 326 candidates from non APARAJITA submitted nomination paper for Reserve seat (Member) Position in UP election 2016 (143 EWRs, 222 PEWRs, 2 NAV and 136 women from non APARAJITA got support from Awami League) and among them 5 EWRs, 4 PEWRs and 4 candidates from non APARAJITA withdrawn nomination paper. 44 EWRs, 295 P-EWRs, 1 NAVs and 66 women from non APARAJITA won in reserve seat (Member) Position. 23 EWR 162 PEWR and 34 non APARAJITA are from AL.

BNP, Jatio Party, Jamat e Islam and other political parties together supported 61 EWRs, 80 PEWRs, and 85 non APARAJITA candidates, all from reserved seats. Other political party also supported one candidate for chairman position and one for general seat.

Two women candidates for Chairman Position and 2 PEWR (general seat) won from Awami league.

212 women candidates won as member of reserve seat with the support of AL, 43 supported by BNP, 3 from Jatio Party, 3 from JI and 130 women elected with the support of other political parties and independents.

Out of total 1600 nomination AL gave 822 (51.4%) nominations. Out of total 410 candidates own AL had 222 (54%) . As such the ruling party dominates in the LG election. This includes two women candidates for Chairman Position and 2 PEWR from general seat.

1.2 and 1.3 which include service monitoring could not be implemented because EWRs were busy with election. Safety net programs are generally operated during Eid festival. During reporting period there was no Eid festival.

1.4: 50% of key stakeholders' proactively influencing gender- discriminatory policies and laws (baseline not available)

Update of the stakeholder analysis: DW is working for 2709 direct stakeholders which includes 536 Elected Women Representatives (EWRs), 1104 Potential Women Representatives (P-EWR), 1070 Volunteers and 1 Women Member of Parliament. In order to implement the planned activities smoothly, DW has interacted with relevant secondary stakeholders including Local Government Institutions (Union Parishad, Upazila Parishad and Municipality), Local Administrations (Central and Local Level), relevant Service Providers (GO-NGOs), Journalists and Community People.

Due to election and newly elected representative who are not yet in operation this issue (**proactively influencing gender- discriminatory policies and laws**) has not been fully implemented.

13 number of news published in different Printing and Electronic Media regarding key stakeholders' proactively influencing gender-discriminatory policies and laws.

106 government officials, 23 civil society representatives, and 3 members of local government association were present in the advocacy event at national level which were organized at local level.

63 government officials, 50 civil society representatives, and 20 members of local government association and one law maker were present in different local level events.

Chapter 3: Outputs & Performance according to the Annual Plan of operation

According to the Annual plan of operation **Democracywatch** has performed to achieve outputs as follow:

Output 1.1.1: As per target 162 EWRs, 340 PEWRs and 22 NAV oriented as potential candidates of upcoming election regarding their roles and responsibilities.

Output 1.1.2:

- 369 Candidates from APARAJITA won as the member from reserve seat (UP) out of 423 seats.
- 43 Candidates from APARAJITA won as the member from reserve seat (Municipality) out of 44 seats.

Output 1.4.1: 9 persons from APARAJITA contested as candidates in general seats of UP

Output 1.4.2: 1227 no of APARAJITA contested in reserve seats of UP

Output 1.4.3: 4 APARAJITA contested as chairman candidate in UP election'16

Chapter 5: Challenges, Lessons Learnt and Recommendation

Challenges:

- Most of the newly elected persons has not yet taken oath
- Newly elected body of LGI did not get charge due to legal restriction.
- Women in politics facing non-cooperation due to Gender discrimination attitude of Community People and Political Parties;
- As per new election rule UP Chairman gets nomination from the political party. This Chairman in order to support the concern political party organizes informal panel of candidates (those who will favor concern political party) to contest for UP election. This process eliminates genuine women to participate as candidates for election both in reserved and general seats.
- Some candidates do not participate in the election or discouraged by the community to contest in the election because they think the candidate will not be able to win the election because of dominance of political party.
- In case of a number of contestants from a particular constituency the political party generally selects one of them but others who do not like to withdraw continues as independent candidates for same constituency which creates confusion among the voters.
- In order create division among the voters so that certain candidate does not win the election, political party or community influential nominates one or more members for election from same constituency.
- Voters in general are not in favor of women contestant for senior position such as UP Chairman or member for General seat in UP election
- General voters does not like to see same face in consecutive terms in reserve seats;
- Women candidates feel that large amount of money will be required for contesting in general seat ;

- The family members, particularly the husbands of the female candidates, do not want EWRs to participate in the partisan election;
- Due to lack of awareness women candidates believe that Reserved seat is better than General seat because of its wider coverage.

Lesson Learnt

- Comprehensive mentoring and coaching with proper planning can enhance EWRs individual capacities & confidence.
- Continuous awareness campaign and motivation can ensure Social Change & Creating Space for Women Leadership
- Adequate information and accessibility can improve the Knowledge level of Women Leaders.
- Yard meetings before election help to identify the actual needs and demands of community.

Recommendations

- Political parties should more strictly abide by regulations on campaign finance and activities.
- Effective mechanisms to monitor compliance with campaign regulations should be developed, and parties and candidates should be penalized for breaches.
- Special arrangements to prioritize elderly, disabled, sick and pregnant voters should be available at every Polling Center.
- Restrictions against unauthorized persons entering Polling Centers should be strictly enforced.
- Children should not be allowed to enter Polling Centers (unless it is necessary in the circumstances, for example a child being carried by a mother).

Annex-1: Cases

Case-1

Sajeda Begum now vocal and aware about her rights



Like many Bangladeshi women who face early marriage, Sajeda has also gone through the same experience. She was forced to be married by her parents while she was only 15 years old studying class 9. Though she was married at the very early age but she had a happy married life along with four daughters and one boy. She was fortunate in the sense that her husband was very cooperative and wanted to see her as a successful popular public figure in her area. Sajeda's husband along with his neighborhood inspired Sajeda to compete in the local UP election reserved seats in 2011. Her husband and neighbors inspiration was a blessing to Sajeda as she won her first election and becoming a popular figure became true indeed. But who knew Sajeda would be facing a tough time at UP in the impending times.

Since the win Sajeda Begum, a EWR of Jessore Sadar has been trying to serve the people of her constituents with limited resources. It has not been an easy journey for Sajeda carrying out her responsibilities as she had insufficient knowledge on the rights, roles and responsibilities. There was hardly anybody who could come up with suggestions and directions in fulfilling her responsibilities. **'We used to come in the UP and go back. It seemed we had no works at the UP. All tasks were performed by male members only.'**

Sajeda replied to a question what was her situation before she got engaged with the project. Sajeda was fortunate finding the APARAJIAT, a project on Women Empowerment directly working their empowerment and capacity building. The project invited and engaged Sajeda in its training session and other programs on communication, negotiations skills in the year 2012. When she became involved with project activities such as trainings, exposures visits, this EWR found her in better positions in terms of knowledge, understanding, communication and negotiation skills.

'After getting training on knowledge, understanding, communication and negotiation skills related to UP now I see that, there are many tasks in UP that can be performed by me. For instance, set up of new roads and culverts, proper and fair distributions of safety net services to beneficiaries. Thus we can serve the public and become popular. I am now more conscious and active than before, she added.'

Sajeda who had very little involvement with the UP, now active with different committees such as chair of Standing Committees on Domestic Violence and Protection, Project Supervision etc. She regularly visits community clinics, inquires about the service quality and goes to different schools to observe the quality of education. She also tries to tag farmers with agriculture department officers for information related to agriculture, cultivation. In addition to service delivery, she also attends in local salish and encourages local people to participate in open budget and other similar activities of parishads. Sajeda Begum Contested in the 2016 UP Election and her result are now withheld.

Case study-2

A success story of an EWR

Krishna Rani (35) is one of the dedicated EWR (35) who lives in Alamsar union under Sripur Upazilla in Magura district. She is a house wife and her husband Noresh Chandra Biswash is a businessman. She is involved with social work and politics for a long time. In 2011 she inspired by her husband to contest UP reserved seat and she won from the constituency of 7, 8, 9 ward. After election she became very disappointed when she found that there was no scope for EWRs to work independently and any specific roles and responsibilities has given by the government. Male representatives also didn't show any cooperation towards EWR.



In this context, she met with APARAJITA Staff and became familiar with the project since the inception. She got training from APARAJITA on communication skills, developing relations with service providers, identifying service providers and its monitoring systems. She was also oriented on leadership skills, LG acts, laws, directives, roles and responsibilities of women representatives. As an EWR, she also involved herself in the salish and village courts. At the same time, she learned many techniques how to ensure quality service from the respective department such as health, agriculture, education, water and sanitation.

In an interview, Krishna Rani said, "With the help of APARAJITA she became more confident to raise her voice against any misconduct". Presently she can easily participate and give her opinion in any meeting or gathering. She regularly monitors school and community clinic to ensure the quality services for poor and disadvantaged citizens. As a result, she was gradually accepted not only by her constitution but also by the union parishad. She also implements several development works like 5.5 km road and 7 km flood-soling road, established 13 deep tube wells etc.

In 2016 UP election, she was re-elected in the same position. She mentioned confidently that in the future she dedicated herself for the voters by whom she was re-elected and next time she will be contested for chairman candidacy. And for this, she is preparing herself and working for building a model UP.

Case study-3 An icon of a social leader

Shathi Begum (35) is one of the icon of social leader who lives at village Magurata, Gala union in Tangail sadar. She had a propensity to serve the people from her childhood. Last UP election in 2011 she was a candidate of reserved seat but defeated only for 27 votes. After election she was little bit disappointed and try to realize why she was not been elected. Since its inception of the APARAJITA She was enrolled as



a PEWR. The project arranged some training session on leadership skills, LG acts, laws, directives, communication, networking & advocacy etc. Later she involved herself with different committees and networks. During 5 years she prepares herself for next UP election and increased interaction among the local citizens with solving problems.

Most significant attempt was to buy an ambulance to give necessary services for local citizen without taking any money. She reached to the patient's house with her ambulance after getting any news of illness. In the middle of the year a freedom fighter Md. Shaullah got heart attack at 4:00am. His family member made a phone call to Shathi Begum. She went over there with Ambulance and took him to the hospital and helped him to get admitted as soon as possible. After his recovery Shadullah shown his gratitude to Shathi and said without her support it would be difficult to survive. Thus many others like Arjina Begum, Vanu Begum, Nupur akter, Helena Akter solved their crisis with the help of Shathi.

Shathi Begum again contested UP election for reserved seat and this time she got her victory. She thought that the reason for her victory was voters choice. She gave her hand for ensuring quality services and local citizen chose her as their representatives also.

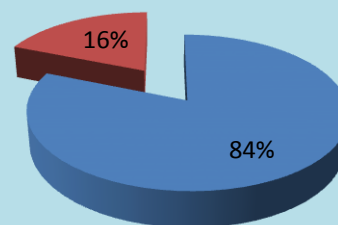
